

PRIVACY POLICY

Using the Website www.mzw.io (hereinafter referred to as the Website) you trust your personal information to Zoomby Games Studio Ltd (reg. № 175,116, address: 4New Horizon Building, Ground Floor, 3½ Miles Philip S.W. Goldson Highway, Belize City, Belize), The Company uses reasonable endeavours to ensure the security of the information you provide and, at the same time, enable you to interact with the database.

Take a close look at the Privacy Policy to be aware of what information the Company collects, for what purpose it is used and how you can change, export or delete thereof.

Using the Website and services thereof, creating a standard user account on the Company's Website (registration on the Website, filling out the forms) means your unconditional acceptance of this Policy and the terms of processing the information associated with you.

In case of disagreement with these terms and conditions, you must refrain from using the Website and terminate the registration process on the Company's Website as well.

1. INFORMATION THE COMPANY COLLECTS

The Company shall collect the following information:

- The data that the user provides in registration (creating an account), when filling out questionnaires and surveys or while using the Website and the services thereof;
- The data being transmitted automatically when using the Website by means of the software installed on your device, including the IP address, cookie files data, the data of services utilization, and other Websites sessions using the Website account, the data on viewing advertisements on the Website, your browser information (or another program that allows you to access the Website), technical characteristics of the equipment and software you use, the date and time of accessing the Website, and other similar information;
- The data and information you send when contacting the customer support.

2. WHY THE COMPANY COLLECTS THE DATA

The Company collects and stores only that information which is necessary in your work on the Website or for execution of agreements and contracts with you.

The Company processes the information you provide for the following purposes:

- Party identification within the services, agreements and contracts;
- Provision of the personalized services and execution of agreements and contracts;
- Communication with you, including sending notices, requests and information regarding the usage of the Services, execution of agreements and contracts, as well as the processing of your inquiries and requests;

You agree that the information you provide will be used by the Company in order to personalize the content.

3. ALTERATION AND DELETION OF YOUR INFORMATION

4. TRANSMISSION OF YOUR INFORMATION

The Company never discloses the data, you provide, to other companies, organizations and individuals not affiliated with the Website. The exceptions are situations:

- You have given your OK thereto;
- Pursuant to the legislation of the country of your stay and of the country of Company registration.

5. PROTECTION OF YOUR INFORMATION

The Company provides for the reliable protection of your information. The Company is doing everything it can to protect the Website users from attempts of an unauthorized access, disclosure, alteration and destruction of the information being stored therein.

What is more, the Company assumes the measures as follows:

- To prevent unauthorized access to systems the Company improves regularly the methods of collecting, storing and processing data, including physical security measures.
- The Company restricts the access of its employees, contractors and agents to personal information, furthermore, the Company puts strict contract commitments upon them for violation of which sanctions or dismissal are foreseen.

6. COMPLIANCE WITH REGULATORY REQUIREMENTS AND INTERACTION WITH REGULATORY AUTHORITIES.

The Company updates regularly the Privacy Policy and processes the users' information in accordance therewith.

7. GENERAL INFORMATION ON THIS PRIVACY POLICY

Cases of applicability of this Privacy Policy

This Privacy Policy is applicable to the Website

Alterations to the Privacy Policy

The Company periodically alters the Privacy Policy on a regular basis; however, in the future, it does not intend to limit the users' rights described in this Policy without their explicit consent.

Legal basis for data processing

The Company processes the Personal Data for the purposes, stipulated in the present Privacy Policy, as set forth above. The legal basis for processing the Personal Data by us will depend on the relevant Personal Data and the circumstances under which the Company collects them.

Nevertheless, as a rule, the Company will collect and process your Personal Data just in cases as:

- when it is required to implement any of agreements between you and the Company;
- it is required to comply with the law requirements;
- it is necessary to protect the legitimate interests of the Company, when this is not in contradiction with your rights;
- and / or in the cases when it is based on your consent.

When the Company collects and uses your Personal Data in the legitimate interests of the Company (or the interests of any other third party); such interests usually cover our interests related to Website operation, relation and interaction with you as necessary in order to provide you with services, legitimate commercial interests of the Company, for example, associated with providing answers to your inquiries, improving the Website, conducting marketing activities or for the purpose of ensuring the Website security, detecting and preventing illegal activities.

In case the Company asks you to provide for the Personal Data in order to comply with legal requirements or to conclude an agreement with you, the Company shall indicate this in a timely manner and shall inform you whether the provision of your Personal Data is mandatory or not (and also shall report on the possible consequences of failure to provide the Personal Data).

The Company stores your Personal Data when there is a reasonable commercial need for such storage, for example, for executing agreements with you, or in accordance with the requirements or assumptions of applicable laws, such as tax laws and accounting legislation.

In case of the absence of a reasonable commercial need in processing of your Personal Data, the Company will either delete or de-personalize thereof, or, if it is impossible, the Company will keep your Personal Data protected and isolated from possibility of any further processing until the moment of deletion to the best of its ability.

8. YOUR RIGHTS

You have possession over the rights in Personal Data protection that you can exercise at any time using email support@mzw.io, and they are as follows:

- The right to access, correct, update or send the request for deletion of your Personal Data.
- The right to be against processing of your personal information when it is based on your legitimate interests, and, separately, the right to refuse direct marketing.
- The right to address us, in some cases, with a demand to restrict processing of your Personal Data or with a demand to transfer your personal information.
- The right to refuse at any time the marketing materials being forwarded by us.
- The right to withdraw at any time the consent for processing of your Personal Data.
- The refusal will affect neither the legality of data processing, which was carried out before your refusal, nor the legality of data processing, which was carried out on other legal basis, different from consent.
- The right to file a complaint with competent authorities of monitoring the data protection, regarding collection and use of your Personal Data. For more detailed information, please contact your local authorities in charge supervising over data protection

The Company shall respond to all inquiries received from the persons wishing to exercise their rights in accordance with the data protection legislation applicable.

In case you become aware of alterations or inaccuracies in information about you, you must inform us of such alterations.

9. MISCELLANEOUS

The Company guarantees that your Personal Data will not be used in any ways prohibited by law, with clear intention to inflict harm to you included.

The Company is not responsible for data loss due to third parties actions, including the hosting providers of the Company, software errors, unreliability of communication channels, as well as illegal actions of hackers and other lawbreakers.

In case the user data loss is detected, the Company undertakes to notify you within 24 hours from the moment of ascertaining the fact of loss, as well as to make all possible efforts to reduce negative consequences and to identify the admins, liable therefor.

When processing the Personal Data, the Company shall take all necessary legal, organizational and technical measures to protect the Personal Data from hacking or accidental access thereto, destruction, alteration, blocking, copying, provision, dissemination of the Personal Data, as well as other illegal actions pertaining to the Personal Data.
